### Cooled Transported Semen Contract

I hereby agree on \_\_\_\_\_, to breed the mare named below to the Stallion:

1. The Stallion Fee is \$500.00 including a non-refundable booking fee of \$200.00 which shall be payable upon execution of this contract. The balance shall be payable prior to the shipment of semen.
2. Mares on the premises of Single B Farm have a breeding priority on any given day; therefore we make no guarantee cooled semen will be available for a specific day, though we will make every effort to supply the semen.
3. There is a \$200.00 charge for each collection and shipment of cooled transported semen. The first \$200.00 collection and shipping fee is due five (5) days prior to the first shipment of cooled transported semen.
4. A request for shipment of cooled transported semen must be made **at least 24 hours prior to shipping time**. Cancellation must be made by 8:00 am shipping day.
5. **A LIVE FOAL GUARANTEE will only apply** as stated below:
  - a) A live foal is described as a newborn foal, which stands and nurses without assistance.
  - b) For mares that conceive from the use of transported cooled semen, a documented ultrasound photo will be required within 45 days from the last date of shipment. If the ultrasound photo is not received, the rebreed becomes null and void. Should the mare not produce a live foal from this breeding, a rebreed will be honored the following year at no additional cost, except for the collection and shipping fee.

6. Single B Farm agrees to ship cooled, transported semen as described above, at the shipping cost to the mare owner. If a mare fails to settle for any reason, mare owner will hold Single B Farm blameless.
  7. A "Breeders Certificate" will be issued for the foal conceived by this mating when all fees and other expenses have been paid in full, and when mare has produced a live foal by this mating.
  8. This contract shall be binding upon the parties hereto, upon execution hereof and the same may not be altered or amended, except by the written consent of the parties hereto.
  9. A photostatic copy, both sides thereof, of the registration papers on the mare must accompany the contract.
